**RE: Oliver McGowan Mandatory Training Code of Practice**

As we write today, 23<sup>rd</sup> August, an accessible version of the consultation on the mandatory training code of practice is still not published.

The consultation started on 27 June but 8 weeks later there is still not a version accessible to people with learning disabilities to support their engagement in the consultation.

We are writing to you as Learning Disability England partners and members: groups and organisations that are led by people with learning disabilities or family members or organisations that support people with learning disabilities.

The provision of accessible information is a right under the law as this [guide](#) from the British Institute of Human Rights states.

We believe that the Department of Health and Social Care should provide this adjustment at the same time as the full version. It is not acceptable that people with learning disabilities do not have equal information or time to think about and respond to a code of practice on training that is about their lives.

Not providing an Easy Read or other accessible version in this situation is of extra concern to us as this training is about people with learning disabilities and autistic people. The training is also supposed to be co-delivered by people with learning disabilities and autistic people. These co trainers are less likely to be heard in this consultation without accessible information.



We have been told that an Easy Read version is in development. Can you please confirm when it will be available and that you will give an extension for responses so people with learning disabilities can be equal part of the consultation?
